## Virginia Nursing Home Overview

- Total licensed nursing homes in Virginia: 287
  - NH beds in Virginia: ~ 33,000
- Majority are certified for both Medicare and Medicaid
  - 6 nursing homes are licensed only (private pay)



## Virginia Nursing Home Overview (cont.)

- VDH Office of Licensure and Certification (OLC) conducts:
  - Biennial state licensure inspections
  - Federal certification and recertification surveys in nursing homes on behalf of the Centers for Medicare and Medicaid Services (CMS)
  - Responds to and investigates complaint investigations, prioritizing those classified as Immediate Jeopardy (IJ).


## MFI Recruiting Results to date since July 25th:




#### **Recruitment Snapshot**

## Plan to Address Training Needs

### **Short-Term**

- 6 Months-Leased Trainers
- Formalized, standardized Program in line with CMS requirements
- Preceptorship of first MFIs with contract labor survey teams
- Partnership with peer states for preceptor opportunities

### **Long-Term**

- Dedicated Training Manager –
   position to post week of 9/8
- Recruiting 2 Trainers dedicated to Acute Care & Long-Term Care
- Employee education, training, certification preparation & annual re-assessment



## **Complaints Intake Process**

### **Current state for Complaint Processing**

- Complaints received by phone, fax, email, or mail
- Triaged by a person, who assigns to MFI teams
- Same MFI teams that conduct surveys process complaint surveys
- Multiple opportunities for failure

Goal: Establish a comprehensive process with automated intake, triaging, notifications, and dedicated complaint investigation teams



### **Complaints Intake Process**

### **Plan for Complaints Intake Process**

- Routing intake process to phone call or online portal
- Automate phone calls into transcripts
- Leverage AI to scan complaints & categorize information
- Objective, CMS-guided triaging of violations
- Automatic notification to facilities of receipt of complaint
- Automated notification of VDH leadership
- Dashboard: Types of complaints, time, past complaints, & responses.

With dedicated teams of MFIs that solely process complaint investigations, freeing separate teams to concentrate on federal and state surveys

Accountability for Protecting the Health and Safety of Residents

2025 Legislation

- VDH is developing procedures to utilize existing statutory authority to suspend / restrict new admissions or to suspend/revoke licenses.
  - Presently, such action must comply with the Administrative Process Act requirements.
  - This can result in a significant time lapse between an incident/event and any sanction.
  - VDH has no summary authority.
- VDH is initiating a regulatory action to implement intermediate sanctions authorized by the 2025 legislation.
- VDH is initiating a regulatory action to establish a new licensure fee structure for nursing homes, as authorized by 2025 legislation.
